## News from the IRS and Massachusetts Division of Public Charities

### Form PC Paper Submissions No Longer Accepted by MA AGO

Effective **September 1, 2023**, Form PC paper submissions will no longer be accepted. Instead, charities will be required to use the new online **Charity Portal** to file Form PC and supplemental materials. Many of you have already received email notification of this change from the **Massachusetts Attorney General's Office Non-Profit Organizations/Public Charities Division (Division)**. To support the sector through this transition, the **Division** will run several in-person filing clinics at locations around the Commonwealth and will host monthly online webinars to demonstrate the use of the Charity Portal. # MA AGO Lifts Form 990 & 990EZ Filing Requirement for Small Nonprofits

As of May 31, 2023, nonprofit organizations with gross support and revenue of **\$25,000** or less are no longer required to submit a copy of Federal Form 990 or 990EZ as part of their annual filings and disclosures. We are pleased with this new threshold which lifted a burden for smaller and volunteer operated nonprofits while moving in closer alignment with other states that require public charities to submit annual financial filings.

## Update to Submitting Form 990-N (e-Postcard)

The **IRS** now offers two sign-in options to submit a <u>Form 990-N</u> (epostcard): Login.gov and ID.me.. Both Login.gov and ID.me provide additional security for tax-exempt organizations by adding multi-factor authentication to the sign-in process. *Previous 990-N filings can be accessed using the same email address associated with your legacy IRS username.*
